2.2 Game Bird Regulations Review

Black Swan Season

The framework for issuing permits to disturb or control game birds for crop protection is currently being discussed with landowners and lwi, with the intention of creating a Memorandum of Understanding and updated management framework for game bird control outside the open hunting season.



Black Swan Season

The August open hunting season for black swans is removed from the Game Notice, and the hunting of black swans shall cease on the last weekend of July.

To assist landowners with any crop predation issues, the existing disturbance or control permit system will be used to access, quantify and manage any issues as they arise.

Gamebird Regulations - Other Changes

Shoveler Ducks

To close a loophole in the aggregate bag limit and to have national consistency, it is the intention to remove shoveler ducks from the total aggregate bag limit on opening weekend and introduce a 2-bag limit for them. This would mean that on Game Bird season opening day a hunter could shoot an aggregate bag of 25 grey/mallard ducks, 20 paradise ducks, and 2 shoveler ducks.

Water Body

Noted that consistent wording was required in the Game Bird regulations and in Schedule 1 when mentioning "water body".



Game Bird Regulation Changes - Other Changes

- 1. **Shoveler Ducks** Remove shoveler ducks from the aggregate bag limit on opening weekend.
- 2. **Paradise Shelducks** In the summer paradise shelduck season, hunting is restricted to locations 200 metres or more from open water.

2.3 Non-Resident Levy - Licence Fee Consultation

Currently, the non-resident levy is used to complement operational activities and going forward should be spent regionally to benefit the fishery that the non-resident angler pays for use. Noted that 84% of total non-resident anglers coming to New Zealand were fishing in the South Island and if funds were shared between regions then they should be ringfenced geographically.

Purpose: To nominate an appropriate person for membership of the Game Bird Habitat trust

Recommendations:

1. That the North Canterbury Fish & Game Council nominate Erin Garrick to the New Zealand Council for membership of the Game Bird Habitat Trust.

Background:

- 2. The Game Bird Habitat Trust exists to distribute monies gathered from the sale of the Habitat Stamp on the game bird licence.
- 3. The Trust has six members, three of which are nominated by Fish & Game.
- 4. The Minister of Conservation appoints the Game Bird Habitat Trust members for three years.
- 5. The current board's term end in September 2023.

Points of Information

- 6. Each year Game bird hunters pay an additional \$5 for their game bird hunting licence to conserve the habitat of New Zealand's waterfowl and upland game species.
- 7. Since introduced by the New Zealand government to "generate revenue" to improve game bird habitat and the habitat of other wildlife, the habitat stamp programme has raised over \$2.5 million for conservation.
- 8. On average, 30 hectares of land each year are protected or enhanced by projects the Trust supports.
- 9. Erin Garrick has moved to the North Canterbury Region this year after serving on Southland Fish & Game staff for almost eight years.
- 10. Whilst there, she was responsible for the majority of Wetland Survey work for Southland Fish & Game.

- 11. Over the last ten years, Southland Fish & Game has assisted in the creation of around 200 wetlands on private farmland.
- 12. Erin has a Bachelor of Science in Animal Science and Agricultural Business and graduated with distinction. She also has a Postgraduate Diploma and Master of Science in Wildlife Management and graduated with distinction.
- 13. She is a recreational hunter of game birds and ungulate species, with a passion for using indicating dogs.
- 14. Her role at Southland Fish & Game oversaw the management of the waterfowl resource in Southland and, consequently, plenty of communication with hunters within the region.
- 15. Erin has governance experience with her appointment by the Minister of Conservation to the Game Animal Council in 2020.
- 16. Erin would be an exemplary addition to the Game Bird Habitat Trust Board; her recent practical experience and knowledge of wetland restoration projects would undoubtedly assist the Trust in assessing projects for the maximum benefit of game bird hunters.

Strategic Implications

17. Supporting Erin with this nomination would assist the council in achieving Priority Outcome One: Our Species populations are enhanced by protecting and restoring habitats.

We are now well into the new year and new salmon season, there have been some good reports of fish around. The main rivers are suffering from periods of low flow and higher temperatures primarily due to low rainfall in the alps. This is exacerbated by a high irrigation demand when conditions are dry. Unfortunately, this situation is predicted to occur more often in the future due to our changing climate. This demonstrates the importance of Fish and Games work such as ensuring the Rakaia Water Conservation is managed correctly to protect the rivers outstanding characteristics.

Currently our summer duck season is under way and hunters have reported some good sessions. Council have slightly adjusted the regulations for next season following staff's engagement with hunters this year during our regulation review.

Council has its annual two-day workshop coming up next weekend, this is where the priorities for the year will be developed. This is the process council uses to determine how to best use our finite resources on behalf of licence holders.

The North Canterbury Council has written a letter to CSI requesting a council-to-council meeting to discuss several matters including amalgamation and Lake Herron/Mellish stream management. (Refer to "For Information Papers for Letter). We look forward to a productive and proactive meeting.

BACKGROUND

The format of the CEO/Staff Activity report has been revised, and with guidance from the Chairman and co-opted Councillors Chris Brankin and Graeme Nahkies we are now testing a different approach.

This Operational Progress Report aims to provide a higher-level outline, but also allow governors an opportunity to ask the CE about things that may have changed in the operating environment (internal or external) or to expand on operational activities and areas of specific interest.

An opportunity to discuss and direct the structure of future operational reporting format will be provided at the Council Strategy and Planning Workshop 18-19 February 2023. With the assistance of council input, it aims to develop into a shorter and more standardised format.

PRIORITY OUTCOMES

1. Our Species Populations Are Enhanced

The Adaptive Sea-Run Salmon Management Strategy is progressing according to plan, and funding for harvest and spawning surveys have now been added to our baseline budget. Increasing costs for aerial surveys (due to rising inflation and international exchange rates) means it is important that adequate monitoring budgets are made available for next year (a \$8,000 cost increase is anticipated).

In order to better understand game bird population trends and sustainability staff have begun a comprehensive review of our regional game bird monitoring activities. Including a detailed evaluation of how population and harvest assessments have been conducted. It is expected this work will improve both our monitoring methods and help staff progress in identifying priority habitats for game bird populations in need of better protection or restoration.

2. Key Stakeholders Are More Engaged

As a result of the establishment of a regional Fish & Game Officer portion focused on compliance, communications, and engagement we are generally making good progress to deliver on this priority. Staff have identified the benefits and need for a regional strategy document to help us guide and monitor progress on the council's two focus areas within this priority outcome.

It will be very useful to undertake a targeted user survey at the end of the financial year, to help evaluate if and how these efforts have improved stakeholder engagement.

3. Participation In Sports Fishing and Game Bird Hunting Is Increased

Progress has been made on identifying and developing steppingstone fisheries near urban areas, see the section on Fish stocking (under Hatchery Operations) in the Operational Progress Report for more details.

A connection has been established with two fishing and hunting clubs run by students at Canterbury and Lincoln University. Both clubs generally have between 150-200 members annually, and discussions for how we can better engage and support/collaborate with them to progress council priority outcomes are underway.

Despite these and other efforts, evaluations of regional sales trends (and their financial implications) have made it clear that it is unlikely that NCFG can meaningfully increase licence sales if we are not given increased support from NZC to do so. Moreover, it has become clear that any staff effort and regional expenditure aimed at increasing licence sales is unlikely to benefit this region as increased sales will essentially be passed on to NZC for redistribution to Grant receiving regions or National Office budgets.

It is essential that Council prioritises engagement with NZC and other Regional Councils to make progress on a national review of Resource Allocation. Until this has been completed the CEO recommends that Council remove or substantially revise their ambitions and focus for this priority outcome.

4. The Council Has Achieved a Positive, Sustainable Financial Position

NCFG is cashflow positive, and regional reserves have been partly restored. While General Reserves are above the 20% of baseline budget threshold level set by NZC, the region's Restricted Reserves have not yet been rebuilt. Regional Asset Replacement and Capital Expenditure Reserves are also not yet at a level that will enable regular replacement of higher-value capital assets long-term (e.g. vehicles, jetboat, electric fishing machine, office premises and rental property maintenance etc.). Additionally, regional fish licence sales continue to decline below sales targets set by NZC. This means NCFG must likely again use regional reserves to complete all our NZC Levy payments.

NZC have also recently proposed concerning changes to how the Non-Resident Levy (NRL) Reserve might be managed that threaten to negatively impact NCFG region's financial sustainability. If implemented the proposed changes will hinder our ability to continue carrying out operational activities and withstand periods of decreasing licence sales. During the last 10+ years, NCFG region has consistently been using the regional NRL Reserve to fund operational activities and has to date spent ~70% of all levies collected. If the NRL funds are centralised by NZC it is essential that the region's baseline budget is increased, to compensate for reductions in expected non-resident fishing licence income (currently likely losses are estimated to be between \$40,000 to \$80,000 per year).

5. The North Canterbury Fish and Game Council Has a Relationship With Iwi In Its Region Consistent With Its Obligations To Give Effect To The Principles Of The Treaty of Waitangi

As a result of staff engagement and the support and guidance of our Statutory Advisor from Nagi Tahu, Chris Brankin, NCFG has gradually been increasing our iwi engagement and relationships.

To progress this priority, and give effect to our obligations under S4 of the conservation Act, staff have been working with representatives from Ngai Tahu/TRONT, statutory management agency roles focused on iwi relations, and other iwi partners around: vehicle access to Te Waihora; the monitoring, management and cultural harvest of native game birds; and how to better monitor and understand if and when threatened non-migratory native fish populations are negatively impacted by trout predation, and how to best address this.

The CE has been working with Steve Carrick who holds the role of Pou Mātai Kō/Cultural Land Management Advisor at Environment Canterbury. This has resulted in improved understanding for how mātauranga Māori/knowledge can benefit and aid environmental protection, and also identified collaboration opportunities. As a result NCFG have been invited by iwi organisers to participate in both a fishery survey at Coopers Lagoon / Muriwai (a small coastal lagoon between the Rakaia River mouth and Te Waihora outlet owned by Ngai Tahu) and also a collaborative mudfish survey and protection project, aimed at making sure trout and other introduced fish are not adversely impacting the recovery of threatened mudfish at a regionally significant native fish sanctuary site in the upper Hororata catchment.

OPERATIONAL WORK PLAN UPDATE

OUTPUT AREA 1: SPORT FISH AND GAME BIRD SPECIES MANAGEMENT Population Monitoring

Game Bird Counts

Annual game bird flight counting black swans and paradise shelducks have been completed. Conducted and reported on a comprehensive review of game bird management in North Canterbury (First draft completed, report due to Council by July/August).

Hapua Surveys

Assisted Environment Canterbury in Hapua surveys at the Waiau River Mouth, Hurunui River mouth and Brooklands Iagoon (Waimakariri River).

Harvest Assessment

Sea Run Salmon Harvest Surveys

Because 2021/2022 Salmon cards continued to be handed in late; staff have reviewed and revised salmon harvest estimates following the recent release of the draft CSI report (see separate sea-run salmon harvest update report). Staff have continued the development of the /2023 season project plan for how to adjust this season sea-run salmon harvest survey method.

Lake Fishery Creel Surveys

To aid monitoring of high-value Lake Fisheries staff have digitised past Lake Coleridge competition data & analysed trends (see separate Lake Coleridge Fishing Competition update report).

Hatchery Operations

Hatchery Facilities

Staff have carried out maintenance and infrastructure inspections at Whiskey Creek hatchery site (currently not in active use after decommissioning in 2019/20). A plan for both short- and long-term maintenance requirements of the site and its infrastructure (water race, vegetation clearance, and fish passage structures) is being prepared.

Fish stocking

A meeting with CCC Parks manager to review how angling should be managed and provided for in both the Roto Kohatu and Groynes Parks has been held. Discussions centred around their importance as steppingstone fisheries, and ways to help ensure the potential for conflict between anglers and other user groups are managed effectively. These parks/lakes represent a significant resource to the urban populations and junior/intermediate anglers. A proposed draft stocking plan for Lake Roto Kohatu has been discussed with CCC Park manager, and an initial small-scale release of commercial-origin juvenile trout and salmon, in preparation for winter fishing activities has taken place.

Regulations

Angling regulations review

Staff have been involved in and contributed to the national Designated Waters/Pressure Sensitive Fisheries discussions, including attendance in NZC and regional meetings.

Hunting regulations review

A review of game bird regulations for 2023/2024 season has been completed.

Species Management and Control

Game bird Control

Staff have responded to queries, evaluated, and processed applications for game bird control permits. Year to date, 5 permits have been issued (1 cultural harvest of paradise ducks, 1 for control of paradise ducks, 1 for control of mallards, paradise ducks, and 2 for control of pukeko).

Sport fish control

Took part in Haldon Pastures mudfish survey in collaboration with ECan and DOC staff. Engaged in the discussions and coordination of proposed fieldwork for a long-term collaborative project with ECan and DOC on trout removal in an important native fish refuge on Bealey Stream near Hororata township.

OUTPUT AREA 2: HABITAT PROTECTION, MAINTENANCE AND ENHANCEMENT

Statutory Planning Process

For a more detailed overview of the RMA advocacy and planning work done to represent the interests and aspirations of anglers and hunters in the statutory planning process see the separate RMA Report.

Fish Screens

Involvement in FSWG subgroup meetings and report reviews.

Access Agreements

Involvement with Greenpark Sands Lake Ellesmere / Te Waihora access working groups, finding solutions to continue allowing hunters to get vehicle access closer to the water's edge.

Te Waihora/Lake Ellesmere Joint Management Plan

Conducted maimai counts & GPS marking on Lake Ellesmere/Te Waihora, aimed at updating our records of hunters who have tagged hides and maimai locations.

Assisted Habitat

General Habitat Enhancement

Staff have been engaged with environmental working groups and forums to advocate for Braided River health. See a copy of the recent joint submission to the Natural and Built Environments Bill we contributed toward here.

General Habitat Assessment

HCWWP Project Support

Fish & Game staff have provided administrative support to facilitate and help this Freshwater Improvement Fund (FIF) project, funded by the Ministry for the Environment, to undertake works aimed to protect vulnerable but valuable waterways and wetlands in the North Canterbury high-country. Our support to the project helps improve environmental protection by maintaining and enhancing the habitat of sports fish and game AND native flora and fauna.

Organised and held the Lake Coleridge Fishing Competition and commenced planning for the 2023 Ranger's Salmon Fishing Competition which is usually held in late March each year on the lower Waimakariri River.

Club presentations, preparation & communications (Christchurch Fishing and Casting club, University of Canterbury FishSoc, Christchurch Rod and Gun Club).

OUTPUT AREA 4: PUBLIC INTERFACE

The key focus has continued to be on working with Iwi partners to identify pathways forward to build authentic relationships, understand engagement expectations, and explore co-management opportunities. Additional focus areas include meeting with strategic landowners and statutory agencies (e.g. LINZ/ DOC) that are involved in the management and access to our key habitats and resources. Staff have also been involved and attended meetings and workshops with other groups e.g., Braided River Action Group.

OUTPUT AREA 5: COMPLIANCE

See the separate compliance report for a more detailed account of ranging activities.

OUTPUT AREA 6: LICENCING

Staff have overseen Licence production and replacement in the office, and partaken in licence database discussions with NZC staff, Regional Managers, and members of NZC's Licence Working Party. Currently, the staff is undertaking preparatory work for the next season's sea-run salmon harvest card.

OUTPUT AREA 7: COUNCIL

Staff have assisted the Council Chairman in administrating the preparation of updates and Reports/Papers for Council meetings and workshops.

OUTPUT AREA 8: PLANNING AND REPORTING

Planning and Reporting

Development of the Draft OWP for the 2023/24 season has begun, and OWP project plans for the current year have been reviewed and updated, and/or scheduled to be completed.

National Liaison

Involvement with NZC Women Anglers survey, correspondence, and planning.

Review of National Angling Survey period data, in preparation for national analysis and management discussions coordinated by NZC.

INPUT AREA 9: ADMINISTRATION

Staff Training

Staff have completed follow-up practical electric fishing training with an external instructor. Further practical training will be provided in late February, along with a theoretical lesson on the principles and safety of electric fishing by an instructor from Smith-Root, who are the manufacturers of the primary electric fishing machines NCFG owns and operate.

Continuing jet boat driver training with Paul Van-Klink in Waimakariri and Rakaia rivers is underway (Harry Graham Samson and Lyndon Slater).

Staff workshop for report writing has been held with the assistance of Co-opted Councillor Chris Brankin.

Our newest staff member has recently completed the CERT course (Matt Garrick) and has also partaken in ranger training at McKenzie hydro canals in conjunction with CSI region.

Office Premises Maintenance

A Healthy Homes inspection has been carried out of the rental property, confirming additional maintenance is required to meet the set National Standard. Discussions with the tenant has resulted in the preparation of a draft agreement for how and when this work can be completed. And some of the more urgent work to maintain and repair the rental property and yard area has already been undertaken and/or scheduled. More maintenance work is still required to ensure the property complies with the Healthy Homes Standard. Plans for how this work can be resourced and completed will be presented at the council workshop (February 2023).

2. RECOMMENDATION

3. POINTS FOR INFORMATION

a. Profit and Loss – Table 1

The Profit and Loss Report reports direct costs for the period stated being December 2022. This Report has been set up in the same format as the year-end Annual Report.

The approved 22/23 Budget used in this Report is \$914,882. This is made up of baseline funding of \$783,400 plus \$91,482 granted from contestable funding. In addition, one-off approvals were given to use reserves totalling \$40,000. (\$15,000 for traffic safety upgrade and \$25,000 for headwater monitoring).

Revenue

- i. Licence sales are received by two methods: Public On–Line is paid to NCFG monthly, and Agency On-Line is earned monthly but paid to NCFG bi-monthly.
- ii. The non-resident licence levy is accumulated over the financial year and is journaled into the Back Country Reserve at the end of the financial year.
- iii. The sea-run salmon endorsement charge of \$5.00 is separated from licence income and is used to offset printing costs for the endorsement card.

b. Balance Sheet – Table 2

i. Accruals: (11.64) Duck Stamp Levy (rounding)

ii. Employee Entitlements: is annual leave and PAYE owing at month end

iii. Income In Advance: \$104,755 - (year-end transaction) – this relates to an accounting accrual for whole season fish licences that still have 1/12th of the licence remaining as at balance date. This will be reversed out and replaced with values as at 31/8/23.

We have had regular safety meetings and training sessions, and our employees have shown a keen interest in learning about best practices in health and safety.

H&S Meetings

8. Weekly heath and safety discussions are a regular part of Monday morning meeting agenda, these discussions provide a useful forum to discuss and improve general health and safety culture.

Staff Induction

9. New staff member Matt Garrick is being inducted and introduced to NCFG Health and Safety systems and processes.

Contractors

10. No new contractors have been inducted or engaged on site.

Staff Competencies and Training

11. Staff competencies continue to be assessed as required. Training plans will be established for all staff to monitor and progress individual needs. As trailers have been identified as a significant risk that have contributed to recently recorded incidents, a competency assessment process has been established.

RECOMMENDATIONS TO IMPROVE HEALTH AND SAFETY

- 12. Conduct regular safety inspections of all equipment and facilities to ensure they are in good working condition and meet relevant health and safety regulations.
- 13. Encourage employees to report all near miss and incident events as soon as they occur, so that we can learn from them and prevent similar events in the future.
- 14. Provide ongoing training and development opportunities to enhance staff knowledge and skills in health and safety.

CONCLUSION / DISCUSSION

15. NCFG are tracking well towards our H&S goals. Further work is required to ensure systems and processes are adhered to and good cultures are developed.

Purpose

1. This report has been prepared for Council to summarise key RMA activities undertaken by the NCFG team throughout the period November 2022 to February 2023

Introduction and Background

2. As the statutory management agency for sport fish and game birds we are required to consider the Legislation, the RMA, local plans, regional plans, and National Policy Statements applicable to our Region.

Analysis

Priority - Regional

Te Waihora Joint Management Plan Access Issues

- 2. NCFG have engaged in a process to resolve issues associated with unmanaged vehicle use in the Te Waihora area. A working group has been established between DOC, Ngai Tahu, SDC and NCFG.
- 3. The primary role of the Working Group is to make recommendations to the Te Waihora Co-Governance Group around solutions to minimise damage and ensure all user groups are provided for. This has progressed to proposing designs for restricting general vehicle access to key sites and providing managed access for the purposes of gamebird hunting.


Rakaia WCO

4. Covered in separate Memorandum

Resource Consents General

- 5. All resource consent applications lodged with the regional council are presented weekly to affected parties to assess whether these are relevant to us. Where relevant we provide feedback to regional councils and where necessary propose these be publicly notified.
- 6. Through the period November–February we have received and assessed 184 resource consent applications of the type and locations presented below and a total for the year of 337.

7. The total consents relevant to NCFG account for 197 of these with the remainder spread between NM, CSI and Otago regions.



Gravel Management Strategy Review

- 8. The Environment Canterbury Rivers team are reviewing their Regional Gravel Management Strategy (GMS) 2012 which sets the framework for managing gravel extraction from rivers across Canterbury.
- 9. In undertaking the review, North Canterbury Fish and Game are working with the Regional Council to articulate the values important to hunters and anglers and propose amendments to the strategy to provide for these values.

Engagement With LINZ

- 10. Due to several issues identified in the management of LINZ properties, NCFG has begun a process with LINZ to build a better engagement framework and improve the way we receive information regarding their permitting process and applications for land use changes.
- 11. NCFG will seek to establish an MOU or formal agreement with the organisation to manage expectations. Our initial planning meetings with LINZ was completed in late October. This engagement will be further progressed through a workshop involving multiple agencies, aimed at helping us all better define the complex interactions we have as agencies.

Update on North Canterbury's Rakaia River issue.

Introduction

Concern amongst river users has been growing for a number of years over changes in river flows and degradation of fishery and other outstanding values in the lower Rakaia River. Perceptions of change in the river was assessed in a 2022 report by NIWA¹.

The leaking of a draft ECan report on water balance modelling for the catchment brought the debate into sharp focus in late 2021and received detailed media coverage. Amongst other things it questioned whether water takes by Trustpower (now Manawa Energy) to supply downstream irrigation complied with the Rakaia Water Conservation Order (WCO).

Manawa's approach to the management of it defines as 'warehouse stored water' in the catchment was enabled by the 2013 amendment to the WCO but was intended to have a neutral effect on the river environment.

ECan distanced itself from the leaked water balance report and issued an amended version excluding the compliance concerns outlined in the executive summary and conclusions. North Canterbury and EDS became involved at that point and North Canterbury's position was communicated in a letter to the Minister for the Environment in December 2021.

North Canterbury and EDS agreed to act in concert on the matter and wrote to ECan through EDS's lawyer questioning non-compliance issues. ECan's response was:

- to downplay non-compliance;
- to assert that they had no responsibility for compliance with or monitoring of WCO provisions and
- to suggest Court proceedings to clarify the issue

North Canterbury and EDS agreed with ECan that declaratory proceedings were the most appropriate Court action and RMA pool funding for North Canterbury's participation was approved by NZC about mid 2022.

Progress since then has been particularly slow with EDS and North Canterbury commissioning legal advice on both the warehouse stored water concept and ECan's responsibilities to enforce and monitor the WCO. There have been ongoing communications between lawyers acting for ECan, EDS and North Canterbury on the legal questions to put before the Court and at the time of writing ECan has still to share its final position on those legal questions and any supporting affidavits.

Recently ECan has re-initiated consultation with river users over issues of concern through a workshop on progress with water balance modelling on 26th January 2023. Another meeting specific to Fish and Game is scheduled for 9th February. ECan have also been actively working with extractive water users on monitoring and compliance issues.

Background

The Rakaia Water Conservation Order (WCO) has been in place on the river since 1988 and specifically recognises fisheries, natural braided river character, wildlife habitat and

recreational amenity. The order was successfully sought by Fish and Game and was amended by agreement in 2013 to enable water to be stored in Lake Coleridge and released into the Rakaia for downstream use by irrigation interests, notably Central Plains Water (CPW). The amendment was granted on the basis that providing for irrigation would not adversely impacting on the health and wellbeing of the river.

However the consensus view amongst recreational users is that there has been continuing environmental degradation in the catchment related the cumulative effects of excessive allocation of water to out of stream uses. Manawa Energy's 'warehouse stored water' regime and CPWs management of irrigation water are recent major elements of water management within the catchment.

Issues

Insufficient environmental monitoring.

There has been a distinct lack of monitoring of river values, including those outstanding values identified in the WCO, before and since the 2013 amendment and there is limited hard data on environmental trends. The only completed work is the NIWA report mentioned above.

There is a reliance on fishery monitoring data and research results from the 1980s because so little work has been done since although some new monitoring projects are underway.

ECan has acknowledged that it cannot link cause and effect within the catchment at present. It notes its current approach to compliance is only picking up 'pieces' of the full Rakaia picture.and says it needs a 'holistic approach to the understanding of the Rakaia so that we can link loss of values with particular drivers'.

River users report lower than anticipated river flows in the lower river and the draft water balance report noted flows at the river mouth were periodically well below the monthly minimum.

Inadequate water use monitoring

ECan's compliance monitoring relies on data collected by consent holders. There is no real time monitoring at present and there are data gaps and some compliance issues which ECan appears to be working to resolve directly with consent holders. Those compliance issues include Manawa Energy's major take from the Wilberforce for supply of stored water.

Warehouse stored water regime

Stored water is the water taken and stored in Coleridge when the river's flow meets the minimum flow and the full 70 cumec water allocation. Stored water is made available for downstream irrigation on request by release into the Rakaia mainstem. The stored water regime was enabled by the 2013 amendment to the WCO but there were changes made to it by Manawa in 2015 and ECan has requested clarification from Manawa Energy over how it is interpreting and managing stored water; how this differs from what was modelled in the 2013 WCO amendment hearing; and over the adverse effects of the change

Subservient water regime

CPW adopted an alternative strategy for using so called 'subservient water' (water not being used by other consent holders) which could be added as 'stored water' and so was outside minimum flow provisions. This approach appears to maximise water use for irrigation but

there is uncertainty over whether CPW's methodology for defining subservient water has been accepted by ECan

Complexity of water management

Water management in the catchment is very complex. There are a large number of consent holders within the catchment and water allocation has been undertaken in a series of 25 or so bands with bands for earlier allocations having a higher reliability of supply that those granted more recently.

Interaction between surface flow and groundwater in the lower Rakaia is not well understood so it is not safe to assume that 'stored water' discharged from Coleridge in fully available to be taken for irrigation downstream.

There has been a significant increase in irrigation demand and allocation in recent decades and significant land use intensification as well.

Lower river flows cannot be continuously monitored so will need to be modelled but there has been a lack of flow gauging in that reach on which to base modelling although that is being remedied with recent work.

ECan's non acceptance of responsibility for monitoring and compliance with the WCO Ecan asserts it has no statutory responsibility for monitoring of outstanding values identified by the WCO or for monitoring compliance with the WCO. Clearly the WCO needs to be supported by ECan through provisions in the Canterbury Land and Water Plan. At present there are strong policy linkages between the WCO and the CLWP so the ECan position is difficult to understand. Declaratory judgement decisions should clarify these issues.

Water allocation limits

The current water allocation limit for the river is 70 cumecs and was set through the WCO in 1988. There is only one irrigation block with a one for one flow sharing arrangement above the minimum. ECan presently describes the river as 'fully allocated' and there appears to have been no consideration of whether that level of allocation remains appropriate in the light of river flow issues and environmental trends

Minimum flows

Current minimum flows for the Rakaia were set on a monthly basis through the 1988 WCO at the gorge. There is no minimum flow set on the lower Rakaia River so lower river flows are not directly protected.

Conclusion

Rakaia River management issues will not be resolved by the upcoming declaratory proceedings but the case is an important step in addressing fundamental questions which will either expose flaws in the planning framework or flaws in interpretation.

The river's problems don't just relate to Manawa Energy's and CPW's activities and their new water management regimes. There are complex cumulative effects at play in a catchment which has sustained massive land use intensification in the last 30 years which has not been matched by land and water resource management.

It seems likely that the WCO provisions are no longer adequate for river protection given those changes but adjustment to the WCO, the CLWP or to consent conditions in response to environmental trends will require a long term advocacy commitment by North Canterbury

COMPLIANCE REPORT

Purpose:

1. To update councillors on the compliance efforts undertaken since the last council meeting

Background:

- 2. There are 21 (six staff and 15 honorary volunteers) effective warranted rangers undertaking compliance efforts for the North Canterbury Council.
- 3. Compliance patrols are an essential part of angler engagement; a visible presence reinforces the value of your licence and increases the risk of non-compliant people getting caught.

Points of Information

- 4. The summer has been a busy period for the Rangers, with at least two days of staff ranging per week occurring since the season began.
- 5. Honorary Rangers have also been out consistently throughout this period as well and have been responsible for detecting most offences. Year to date, about 750 licence checks have been conducted, representing ~63% of our annual fishing licence compliance target.
- 6. In addition to undertaking checks at regular high angling traffic sites, a wider variety of remote angling locations have also been targeted this season. While they seldom generate high numbers of licence checks, the visibility and engagement generated by patrolling remote areas is important. As an indication of their increased efforts, it is worth noting that one honorary ranger racked up ~1500 km of travel over the Christmas holiday period, checking licences across the Lewis Pass area.
- 7. Other honorary rangers have undertaken tasked patrols to target areas where known salmon angling interest was peaking.
- 8. Ranging patrols have been aimed at a mixture of high angler-use areas such as river mouths and more remote fisheries that haven't been visited as often in the past.
- 9. A weekend operation in the Lake Summer area combining boat and vehicle patrols over three days in early December was effective in showing the Fish & Game presence in the area.

- 10. The Lake Sumner operation was covered in local media (North Canterbury News), NCFG Facebook page and weekly fishing report.
- 11. The rangers have had a key focus on sea-run salmon harvest card compliance.
- 12. Overall, salmon harvest card compliance has been excellent, with only a very small number (less than ten) having had Failure To Produce Offence Notices written up for not having their harvest card on them.
- 13. Anglers have been reminded that they must have the means to write in their harvest immediately once a fish is kept, and the return deadline (7 May 2023) for that information.
- 14. This means anglers cannot have an electronic version of their temporary card unless they have the means by which they can edit that temporary card.
- 15. Other offences detected during this period that are currently being processed are Fishing without a licence (five people), taking salmon without a sea-run salmon endorsement (one Junior licence holder), and illegal bait (another Junior licence holder).
- 16. Kahawai angling in the Waimakariri River has led to several calls to the office; rangers have been recording details of anglers fishing for Kahawai and informed them about the requirement of releasing any salmon or trout caught unharmed.
- 17. In June 2021, new powers were given to Rangers under the Freshwater Fisheries Regulations, requiring freshwater anglers to provide names and addresses, DoB, and residential addresses with photo ID to rangers.
- 18. Ranger training days have been booked for February 28 (with an angling focus) and April 16 (with a pre-game bird season focus), along with another scheduled weekend operation with joint staff and honorary rangers.
- 19. To improve the management of compliance efforts and volunteer ranger activities, a new online reporting form has been created. It is now live with our rangers and offers staff the ability to gather more data about their ranging efforts and locations.
- 20. The new compliance reporting forms also offers increased privacy and security around limiting access to licence holder details.
- 21. New ranger caps are being issued; these are blue and match a national format that brings Fish & Game into a consistent line with MPI Fisheries and NZ Police staff.
- 22. The Annual Rangers Fishing Competition and the social day is being held on 31 March 2023. Under the Freshwater Fisheries Regulations, we do not need to apply for a permit to have this competition, but we include it in this report to inform Council that the competition is being held.

Subject: HIGH COUNTRY WETLAND & WATERWAY PROTECTION

PROJECT

Purpose

1. To provide Council with an update on progress within the High Country Wetland & Waterway Protection Project.

Background

- 2. The primary objective of this project is to improve spawning and rearing habitat in the head waters of the region's key rivers.
- 3. Time wise the MfE partnership aspect of the project centred on the Glenarrife Stream has reached the halfway point.
- 4. This project will create a wetland on Glenarrife Station that will be in two parts, one owned by the Station, and one by North Canterbury Fish & Game. These land parcels will be placed in QEII Covenants to protect them.
- 5. The project also seeks further habitat enhancement through land retirement above the wetland site.

Points of Information

- 6. Title has yet to be issued to complete the land sale. Staff are following this up regularly with the vendor and the project governance group are confident that there is no problem.
- 7. Lack of title means some activities like covenants are delayed; however, staff have worked to prepare to progress these as soon as possible.
- 8. Staff secured a sponsorship of \$70,000 from Rakaia River promotions. In conjunction with the \$50,000 received from Trust Power's Rakaia Enhancement Fund, this will enable approximately 24ha of streams and wetlands to be fenced and retired from grazing in the Glenariffe headwaters.
- 9. Issie Barrett from Canterbury University visited Glenariffe on 14 December. Her stream-based traps indicated good ecological health with signs of increased colonisation of some species in the recently retired area of the East branch of the Glenariffe.
- 10. Staff completed quarterly reporting to MfE.
- 11. A key focus of the coming quarter will be to progress project deliverables as far as possible to allow staff to spend time exploring options for a second project.
