3. FOR DISCUSSION

3.1 Game Bird Regulations Review

The communication processes through social media and how to better NCFG's engagement with stakeholders was discussed.

Process for the Game Bird hunting regulations review submissions was explained, with a summary of public and staff's recommendations going to NCFG council meeting in November 2022.

4. NZC GUEST SPEAKERS

4.1 NZC CEO Corina Jordan

Corina Jordon gave her background prior to her appointment as CEO of Fish and Game New Zealand. C Jordan than outlined her vision on what Fish and Game New Zealand would look like in the future. She saw the biggest challenges were in retaining F&G's social licence, changing the current culture and its leadership model to improve how regions collectively work on enhancing our social licence and culture of F&G.

4.2 NZC Chairman Ray Grubb

Mr Ray Grubb, Chairman of the New Zealand Fish and Game Council (NZC) and the Chairman of the Implementation Steering Group who is responsible for the current F&G review was introduced.

He spoke of the F&G governance review, of the role of NZC governors, of the proposed national centralised funding model and what he thought was the future for the Resource Management Act and relationships with other organisations eg. Iwi, ministers of government.

5.1 General Business

1. Staff to look at new fence blocking access at Lake Wairewa (Lake Forsyth)

2. Discussion on NCFG's shortfall regarding angler engagement including a higher level of communication to stakeholders

6.1 Chairman's Report

A brief discussion about the benefits and possibility of looking into setting up a Charitable Trust in the USA to receive donations, like the Auckland / Waikato Council have done, was held. It was broadly agreed that this matter could be something to look at. In addition, the frequency and benefits of having chair to chair meetings between ECan and Fish & Game Councils was discussed.

6.2 CEO Report

A discussion about the Standard Reports indicated that holding a workshop to consider changing the structure and format of staff reports to council may be a helpful step to focus reporting on the council's key priorities, but also satisfies ongoing requirements to report on statutory functions and OWP projects. It was agreed that a workshop to progress work on this topic be planned.

6.6 NZC Report

A brief update on NZC's use of its Executive Committee and its intention to review the number of members it has (3 currently, but possibly 4 going forward) was provided, followed by a brief discussion. Governance Advisor Graeme Nahkies explained that the use of Executive' Committees was generally considered an outdated practice and discredited concept, since they easily undermine council unity and erodes governance capacity. Executive Committees often risk becoming a mini-council which exclude non member from important decisions and information.

6.7 RMA Report

It was acknowledged that it would be a long process to seek clarification on potential breaches of key water takes and / or water diversion resource consent conditions, as well as the ECan's ability to investigate non-compliance with the Rakaia WCO. Council and the public were informed that in addition to the Rakaia WCO process NC Fish & Game are also meeting with local representatives from LINZ to discuss current and future management and protection of public land, and to explore if some form of MOU may help improve communication pathways around issues relating to statutory functions aimed at protecting environmental values and public access.

7. PUBLIC SESSION

7.1 Public Session

NZSAA Chairman stated oxygen meters are currently being used in the Waimakariri River to collect scientific data on water temperatures.

The AGM of the NZSAA was to be held in a few weeks time, with the 50th anniversary celebrations being held on 20 November at the Kaiapoi Working Men's Club.
