Fish & Game Taranaki is one of 12 Fish and Game Councils accountable to manage, maintain and enhance sports fish and game birds, and their habitats, in the best long-term interests of present and future generations of anglers and hunters. We are a not-for-profit organisation, funded through the sale of fishing and hunting licenses.

There is a National Council whose membership is 12 councilors elected within each region by the people who buy hunting and/or fishing licenses. The function of the New Zealand Fish and Game Council is to develop in consultation with each of the regions the effective implementation of relevant policies established under the Wildlife Act 53 and other applicable acts



The Role

The Fish and Game Officer contributes to fish and game management activities in the Taranaki region (and occasionally Wellington region) working usually independently with minimal supervision and with support from the Senior Fish and Game Officer or Regional Chief Executive
