I'm a passionate duck hunter and fisherman. I've enjoyed five terms as a councillor and want to represent those wanting to preserve the great hunting and fishing we have here in Southland.

With complaints from kiwi anglers on the rise again over the return of foreign anglers and guides I believe there's an opportunity to bring in some sensible regulation to ensure that kiwis can have a fair crack. We don't want our rivers to become like the Great Walks where kiwis miss out on access.

I want to see a guides licence introduced so that guides, particularly foreign guides, can be managed and potentially capped if needed.

When I'm not out hunting with my dog and kids you'll find me shooting claybirds. I'm a current NZ team rep in skeet shooting and love coaching gamebird hunters on ways to improve their skills to ensure more success in the field.

I believe we're the duck hunting capital of NZ. I want to ensure we continue to have season lengths and regulations based on good science to allow this to continue.

With the Ministerial Review findings still being implemented we need licence holders in charge of the decision making. The findings were significant. Changes do need to be made. As licence holders we need to do what's required to future proof our organisation. We need experience around the table.

A vote for me will be for someone who will fight for Southlanders to continue to be able to hunt and fish.

 Tourist Angling overuse. Currently our best fly fishing rivers are being overused by nonresidents at a ratio of two non-residents to one resident. This needs managed.  - Government review. Progressing slowly but may have good outcomes for Southland. Need to keep a close eye on it.
 - National council reviews. Funding review of special interest to Southland.
