F&G currently faces multiple threats: diminishing water quality, diminishing wetlands, increasing loss of access to our lakes and streams and the possibility of bird flu. We must address these threats head on and quickly. Continued legal access to all our Rotorua lakes is a priority. Attempts by anyone to change or close off what is legally enshrined within any settlement agreements regarding continued access for ALL New Zealanders must be highlighted and challenged. Left unchallenged, the subsequent domino effect will impact on many other lakes, streams, and waterways across NZ.
