#### 11. REGIONAL STRUCTURES

Discussions included the following points

- The merger of 3 regions may not necessarily achieve the purposes of 26Q of the Conservation Act given the merger recommendations are based on funding implications of where people buy a licence rather than where they hunt or fish.
- There was an acknowledgement that a smaller number of Councils would in theory lead to quicker decision making and more consistent national policy implementation.
- Concern was expressed that no detailed investigation has been undertaken into regional merger costs such as change of ownership on Para Wetland land titles, Top Valley WMR, Richmond office building, Wairau hatchery sublease/consents/MPI hatchery licence etc.
- Regional representation will be completely diluted through a 3-way merger meaning the need for at least 12 <u>elected</u> Councillors, and the proposal for 4 Government appointed Councillors was rejected.
- The original feedback from Nelson Marlborough Fish & Game around a boundary adjustment to take in the Northern West Coast including the Karamea catchment still stands any such boundary adjustment would make this region even more than self sufficient funding wise into the future this option was not considered in the Hunt report.
- The Council reflected they would have considered further discussion/engagement as per the earlier letter to NZC from the 3 regional chairs but now have serious reservations given West Coast have now stated emphatically they don't support a merger.
- A response to the West Coast letter from NZC would be helpful to assist with any further merger discussion.

These points and a request for a formal response from NZC around whether serious consideration to centralising the licence fee was being undertaken would be sent to NZ Council Chair.

# 12. DRAFT SPORTS FISH AND GAME MANAGEMENT PLAN.

Discussion on this document was held over to the next meeting, the Manager will see if there is a planner available to look at this for us.

### 13. DOC LIAISON

Chris Golding attended the meeting and updated the Council on relevant topics. One update was on DoC's eradication project of pest fish around the region. The question was asked if NMC was considering a change to the current regulations pertaining to fishing for coarse fish in this region. Staff recommended that there be no change to the regulation that fishing for coarse fish is prohibited in all waters of the Nelson Marlborough Region. Council concurred with this recommendation.

J Willis noted FG needs to accept Tony Orman's letter and information around forestry issues but note that the situation described is actually a failure of regional Council and management and Government Policy.
