#### **3.** Welcome

Cr Strong welcomed everyone to the meeting. Points raised in his introduction;

- Currently focusing on what is best for the resource and stakeholders going forward;
- The death of Councillor D O'Neill;
- That only minor items were outstanding from the 10 recommendations NCF&G were required to carry out as outlined in the 2018 Audit Report;
- On behalf of Council thanked R Cosgrove for stepping in as Interim Manager for NCF&G during a very difficult time;
- Introduced R Gabrielsson as the new Chief Executive of NCF&G. R Gabrielsson gave a brief presentation on his background;
- That the new adaptive management strategy for sea run salmon would be implemented in the 20/21 fishing season;
- Concerns regarding Plan Change 7.

### **Confirmation of Minutes from the 2018 Annual General Meeting** 4. The following amendments were made to;

Under Item 8 - Summaries of Issues and Achievements 2017/2018

The Youth Programme had a successful year integrating 30 schools around the region. The Programme had to be terminated however due to reduced hatchery output and lack of funding; Under Item 9 – Annual Performance Report

Accounts showing a surplus due to a Bequest of \$500,000.00 received during the financial year.

#### 5. **Summary of 2018/2019 Issues and Achievements**

R Cosgrove explained the implementation of changes that had been required from the 2018 Audit during his tenure as Interim Manager from February to October 2019.

R Gabrielsson explained the challenges ahead which included resetting the direction for NCF&G. To safeguard the resource for the future, careful consideration would be given to the responses to the National Freshwater Reform, the Bio Diversity Strategy and Plan Change 7.

### 6. Presentation of the 2018/2019 Annual Report

C Veitch explained the \$173,102 deficit was due to income being under budget and a \$50,000.00 error in last year's reporting. The write down of fish stocks had also impacted nett profit.

R Gabrielsson explained the hatchery rearing and release strategy was being reviewed and a press release would be forth coming prior to Xmas.

R Gabrielsson spoke on future strategies with ECan regarding water flows / kermecs / water allocations to users and how staff would address these concerns.

## 7. Presentation of the Ian "Mac" McCrory Volunteer Trophy

R Gabrielsson gave background to the Trophy prior to presenting it to Mike Agar. He thanked M Agar for his dedication and contribution towards running the hatcheries.

### 8. Presentation of the 2019 Environment Awards

R Cosgrove gave a quick brief on the recipient of this years' award, Leeston dairy farmer John Legg. Since returning to the farm seven years ago, the farm has taken on a regenerative approach with the view that agriculture is a biological system and not a chemical one. Award to be presented to J Legg at the February 2020 Council meeting.

### 11. General Business

Points raised:

- Due to a change in management, the gates to Lake Pearson remain locked;
- Concern over variance in weights of fish in Lake Coleridge R Gabrielsson stated a project to gather data on fish weights would be looked at;
- That staff would work on a project alongside Trust Power to open camping sites in the high country;
- Concern raised on the year-round season and the use of boats on Loch Katrine as it was being over-used and on the protection of spawning streams in the area. Lack of policing in the area was a concern also. Staff to visit area in new year;
- As black shags were a protected native species and managed by DoC and Iwi, they could not be added to the gamebird list;
- In answer to what the Council was doing regarding spays in waterways, R Gabrielsson responded that the core priority was to look at saving waterways that could be saved and were good now. R Gabrielsson stated there needed to be work carried out on lowland stream degradation.
