6a i Appointee to NZC

Cr Strong advised the resignation of Cr Knight from both NCFG and NZC Councils.

6a ii. Improving Future Council Diversity

6a v Applications to Hold a Fishing Competition

1. New Zealand Salmon Anglers Association (NZSAA)

C Eaton explained they were currently updating their rule book for the competition due to new fishing regulations and Covid 19. Noted that heads and stomachs of salmon caught during the competition be kept for analysis by fish and game staff.

"That approval is given to NZSAA to hold their fishing competition on Saturday 13th March 2021."

2. Rakaia River Fishing Promotions (RRFP)

W Eastwick explained the changes in the way they would be running their competition including a special category/prize for catch and release.

6b i Review of Reserves Policy

Cr Strong updated council on the correspondence about the discussion document provided by Ray Grubb. It was discussed that this was not a policy document only a discussion document and agreed that feedback would be provided by NCF&G.

6b ii Resource Allocation Review Update

Cr Strong reported he was on the steering committee for the reference group who report back to NZC for the resource allocation review. The review is partially funded by DoC with independent review results to NZC after Christmas.

6b iv Increasing Opportunities – Summer Duck Hunting

NCFG Council was asked to consider and discuss the test/possible introduction of a summer duck hunting season in early 2021. The possibility to have a summer endorsement on the gamebird licence to enable targeted research was discussed. Concern was expressed on the effect a summer season would have on populations. Would need very careful monitoring.

"That the NCFG Council support the proposal in principle and ask staff to provide a feasibility study and discussion document on any rule change for a summer duck hunting season by December 2020."

6b v Gamebird Regulation Submission from Christchurch Rod and Gun Club

A submission for a rule change to the pheasant season – extending the season to three weekends instead of one (one weekend over June, July and August) was received.

6b vi Licence Sales Trends in the North Canterbury Region

Concern was raised that South Island regions continue to heavily subsidising North Island regions. More work required to capture lapsed licence holders.
