- NCFG 10 Year Salmon Management Plan expecting confirmation from Government early March 2021 on season bag limit change.

6. MEETING BUSINESS

6a i Gamebird Regulation Options

Points raised in discussion:

- Have season for mallards same as CSI as more sensible to have same weekends;
- Measure outcomes;
- Recommendations decided on last three years of surveys;
- Status quo on other regulations.

"That NCFG Council adopt the following staff recommendations:

- 1. Open a summer mallard hunting season on the first two weekends in February (in line with CSI), with a daily bag limit of 10 mallards. This will apply to both areas A and B. Hunting is only permitted over paddocks and must be more than 200m from any water body.
- 2. Extend the pheasant hunting season from one weekend to three weekends being the first Saturday in June (excluding Queens Birthday weekend) with a daily bag limit of one cock pheasant.
- 3. If approved, it is also recommended that any potential impacts, adverse or otherwise, of these regulation changes be monitored with the use of additional phone harvest surveys to cover these periods."

6a ii. Co-Opt to Council - Selection Process

Cr Strong advised positions were advertised with 25-30 people expressing interest thus far. Decision taken to look at three people to co-opt to Council with the remaining forming a focus group to assist Council with outlining a 10 year salmon management plan.

Cr Strong to follow up with Emily Craig as possible candidate for co-option to Council.

Process:

That a selection committee be formed from interested Councillors.

"That Cr's Musson, Isitt, Coll and Henderson from a selection committee to coopt members to Council".

- 3. Send reminder to candidates two weeks prior to January meeting.

6a iv. Funding for Winding Creek Weed Spraying

\$5,000.00 was sought from each organisation regarding a three-way contribution between NCFG, DoC and Flock Hill for weed control.

"That staff conduct a site visit to inspect the weed control issue and meet with representatives from Flock Hill to explore options for developing a long term weed management plan for the buffer zones retired from grazing to protect freshwater values".

M Bate presented a slide show on the lack of aquatic life and bird life around the Ararira / LII River, Te Waihora / Ellesmere and Harts Creek/Waitatari. He wanted more pressure to be put on ECan to stop the alleged chemical weed spraying.

Cr Strong agreed that NCFG want the problem fixed as well. R Gabrielsson to write a letter to the Ararira / LII River Committee stating concerns. M Bate to be kept informed.
