Cr Stong apologised that the Statement of Service Performance was in draft only as still working through the process.

Points to note;

- 3. Of the \$122,400 deficit, \$49,000 was approved from Reserves, approximately \$31,000 was required to be capitalised and the balance was explained for Council approved spending, unbudgeted repairs to the jet boat and aviation fuel increases for fish and game bird monitoring flights.

2.3 2024 GAMEBIRD REGULATIONS

The current procedure for regulations changes requires to be reviewed due to the recent lack of stakeholder engagement. Noted that social media gained more traction then other media platforms used. A good communication process on educating stakeholders around the perceptions of game bird bag limits was required. The question on the frequency of the game bird regulation changes being reviewed bi-annually rather than annually was asked.



Game Bird Regulations Review - Staff Recommendations

That Council approve the staff recommendation for changes to the game bird regulations as follows;

1. Reduce the opening weekend greylard duck (being a mallard or grey duck or any hybrid of those species) daily bag limit to 15

- 2. Reduce regular season paradise shelduck daily bag limit to 15
- 3. Reduce summer season paradise shelduck daily bag limit to 10

4. Increase chukar daily bag limit from 0 to 2.

2.4 CREATION OF A DEDICATED RESERVE FOR HABITAT ENHANCEMENT PURPOSES

The allocation of prosecution income towards habitat enhancement and protection would increase Fish and Game's social licence and reach habitat protection goals. This account would allow for discretionary funding from NCFG staff toward habitat work including planting, wetland restoration/creation projects, habitat contract work, stream restoration, etc. Staff would recommend projects/expenditures toward the Chief Executive for approval to deliver on Council priorities. Expenditures and income for this account would be reported on annually to demonstrate progress on Council priorities
