1531 Prosecutions

The manager advised on the progress of prosecutions and potential diversion funds donated to Game Bird Habitat Trust. Barry Barnes spoke on behalf of NZ Council stating a diversion scheme proposed is progressing. Cr. Daniels suggested those prosecuted for not having a game bird licence should be made to purchase one. The Manager will investigate this as a possibility. Cr. Skeates enquired about making public the outcome of prosecutions as a deterrent. The manager intends to.

Councillors discussed problem birds and improving connection with landowners. Lloyd Altham suggested an interest article in farming magazines prior to the game bird season.

1840 National Liaison
