ELECTION OF MEMBER OF NEW ZEALAND FISH AND GAME COUNCIL

The election of a member of New Zealand Fish and Game Council is governed by Section 26D (2) of the Conservation Act 1987, which reads;

26DMembership

(2)

Each Fish and Game Council shall be entitled to appoint one of its members to be a member of the New Zealand Fish and Game Council, and any person so appointed may from time to time be reappointed.

The role of National Councillor is an important one. Besides filling the normal role on Taranaki Fish and Game Council, the National Councillor will need to be available for about six meetings per year of the New Zealand Council, each of which normally takes a whole weekend. When acting as a National Councillor, a member is expected to represent the interests of anglers and hunters generally rather than representing Taranaki Fish & Game Council.

National Councillors are not paid, but all costs of travel, accommodation, meals and incidentals are met by the New Zealand Council.

MINUTES OF THE MEETING OF THE TARANAKI FISH & GAME COUNCIL, HELD AT TET MULTI SPORTS STADIUM, STRATFORD ON 19 OCTOBER 2024 COMMENCING AT 10:00AM

1. The Chairman, Chris Donald called the meeting to order at 10:00am.

The Chairman welcomed Councillors, staff, Rawenata Saunders and Chris Mattock to the meeting.

A Karakia was given by Councillor Alan Flynn.

The Chairman asked for 1 minute silence to acknowledge the passing of Councillo David Potroz.

PRESENT

2. APOLOGIES

Apologies were received from Paul Blewman.

3. CONFLICT OF INTEREST

The Chief Executive noted his conflict of interest being that he also manages Wellington Fish & Game Council. There were no other additions noted to the Conflicts of Interest register that had not already been declared at previous meetings.

4. MINUTES OF THE PREVIOUS MEETING 17 AUGUST 2024

MOVED SARGESON NANCARROW

THAT THE TARANAK FISH AND GAME COUNCIL ADOPT THE MINUTES, WITH AMENDMENT NOTED OF THE MEETING HELD 17 AUGUST 2024 AS A TRUE AND CORRECT RECORD CARRIED

5. MATTERS ARISING

Councillors Donald and Nancarrow noted the new name for their club – Inglewood Rod, Hunting and Clay Target Club.

Action List Summary

Allen Stancliff discussed collating information to be able to develop an access and information pamphlet for perch fishing, noting that there was already information available to initiate such.

6. NZ COUNCIL BUSINESS

a. NZ Fish and Game Council appointee, Gerard Karalus gave a summary of the latest NZ Council meeting held on 23 and 24 August 2024. He noted:

- The Minister for Hunting & Fishing, Hon Todd McClay, attended the meeting. He noted that if Fish and Game wanted any legislative changes to the organisation that they be presented as a package rather than piecemeal.
- The Annual Meeting & Budget timetable had been approved by NZC for consultation.
- The NZC approved the total national budget.
- He noted that Auckland/Waikato Fish and Game Council had undertaken a vote of no confidence in their NZ Council appointee, who was also the NZ Council chairman. There doesn't appear to be proactive processing to replace or remove their appointee for the short period i.e. after the elections when a new appointee would be elected (with a deadline of 3 weeks after declaration of results).
- He noted that following a recent Appeal Court decision that supported the original Environment Court decision regarding regulatory requirements for farming sparked Southland Federated Farmers to make strong and unfavourable media commentary towards Southland Fish and Game Council. The Chairman noted that he would be reaching out to the executive of Taranaki Federated Farmers in the region to maintain an open dialogue about advocacy positions.

6b. Changes in approach to Budget Process

The NZC resolved that there will no longer be a contestable fund budget round. Instead NZC, on an annual basis, will be taking a zero-based budget approach. Whereby the entire budget of a region, will be reviewed annually.

6c. Other NZC Business

6d. <u>Draft Policy - Consultation on Sports Fish and Game Bird Management Plans</u>.

The CE noted that NZC required feedback on this draft Policy and guidelines – with the main differences being suggested involved an early engagement with affected parties, particularly mana whenua, as the initial first step. Councillors queried whether Taranaki and Wellington Council's would have their own separate management plan, or whether a joint one would be produced. This would depend on progress of enabling legislation and pace of amalgamation but noted regardless of that development of the Management Plans would proceed with early engagement of affected parties.

6e. Draft 2024/2025 NZC Meeting and Budget Schedule

The draft 2024/2025 NZC meeting schedule was discussed and would be used as a basis for Taranaki's 24/25 meeting schedule for the 2025 calendar year.

7. PUBLIC FORUM

The Chairman introduced Jack Harland who was recently appointed as Field Officer for Taranaki Fish and Game Council and was attending his first Fish & Game meeting. Jack provided a brief resume of his background, noting his relevant academic studies, previous experience with Otago Fish & Game (part-time position), and indicated a strong passion for outdoor pursuits including freshwater fishing.

8. CHAIRMANS REPORT

The Chairman provided a verbal overview report of key issues since the previous meeting.

He noted the actions of other Fish & Game Regions that had created internal organisational instability and increased risk of external intervention. This included potential changes to NZ Council membership which may potentially change to more regionally focused outcomes which could impact budgeting systems and resource allocation. He considered it would be preferable not to progress the amalgamation with Wellington Fish & Game Council, at this

stage, but to continue to align operations. This may contribute to the stability of the organisation by maintaining two votes at the NZ Council table.

He considered that a joint meeting with the newly elected full Wellington Fish & Game should be planned soon (potentially Palmerston North) to confirm alignment of the thinking and approach being taken, which could also include a governance training module.

The Chairman noted this is the last meeting of this Council and wanted to note the dedication from the retiring councillors, Paul Blewman, Craig McEwen and the late David Potroz.

c. <u>Discussion on Topics for Formalising Taranaki - Wellington Arrangement</u>

It was agreed that topics for formalising Taranaki – Wellington regions' arrangements moving forward would be a principal purpose of a joint meeting with Wellington Fish and Game Council.

10. STRATEGIC MATTERS

a. Risk Management Review

The CE updated Councillors on the risk management issues associated with:

- Avian influenza H5N1 Strain (HPAI High Pathogenic Avian Influenza) no change is risk
 level
- Golden Clam samples found in accommodation lodge at Owhango, and Horizons Regional Council had been promoting a Check Clean and Dry approach to ameliorating the risk of small clams attacking to gear.

b. Iwi Engagement

It was noted that Te kopuka has requested formal confirmation of Allen Stancliff as Fish and Game's representative.

Allen Stancliff noted his attendance at the last meeting held in Raetihi on 27th September 2024 and noted that he would be unable to attend the next meeting to be held at Kakahi Marae on Friday 13th December. Adam Daniel of Auckland / Waikato Fish & Game will be encouraged to attend as an alternate.

c. 5 Year Strategic Plan - update

The CE presented an updated Strategic Plan to include the 2027/28 year. The 5-year strategic plan will not be included as a regular agenda item but be sent to Councillors appended to their meeting agendas and reviewed at future February meetings with additions and amendments recommended by staff.

11. POLICY AND LEGISLATION

a. Wildlife Act Review

There has been no update from the Minister of Conservation as to the priority, extent, or timetable in processing this review, but it was confirmed that there is still active review being undertaken of the Wildlife Act and Conservation Act. It was noted that EDS released another volume of policy work to advocate for updating the Wildlife Act and Conservation Act to prioritise native biodiversity, and that NZ Council had responded accordingly in the media to advocate for acknowledgement of valued introduced species.

b. Resource Management Act Review

It was noted that RM Reform - Resource Management (Freshwater and Other Matters)
Amendment Bill for resource management legislative review was being progressed by
Government. The Draft Bill excludes the hierarchy of obligations in the National Policy
Statement for Freshwater Management (NPS-FM) from resource consenting. NZ Council staff
have met with the Select Committee to present a submission.

c. Fast Track Approvals Bill

It was noted that the Select Committee hearing submissions on the Fast Track Approvals Bill had concluded their proceedings and were currently considering feedback for a report back to Parliament before any amendments are made to the detail of the First Reading of the Bill. On October 6, 2024, the New Zealand government announced the inclusion of 149 projects in the Fast Track Approvals Bill

d. Arms Act Review

It was noted that the Government is advancing consultation on amendments to firearms legislation. They have indicated that this may include rewriting the Arms Act 1983, transferring responsibility for that Act to the Ministry of Justice, and transferring the Firearms Safety Authority to another department such as the Department of Internal Affairs.

e. Organisational Policies

The CE provided an overview of the draft Vehicle Use Policy and its purpose. The high level principles reflected

- The Council will provide a safe vehicle and ensure that it is well maintained.
- The employees (and volunteers) will conduct themselves with a safe approach that complies with health and safety, and traffic regulations.
