Results of Sport Fish Regulations Survey, November 2021
Baylee Kersten, Fish & Game Officer, November 2021

Summary

West Coast sports fishing licence holders were surveyed regarding three regulation proposals as part of the West Coast Fish and Game Council's three yearly regulation review. The survey revealed that it is estimated; 88% of licence holders support the implementation of a season bag limit of six sea-run salmon on the West Coast, 77% of licence holders support the implementation of a single hook rule for South Westland lakes, and 84% of licence holders support the closure of Lake Haupiri over the winter season. Anglers were also asked if there were any other regulations they wish to be considered for change, and they are now listed in the appendix five for the Fish and Game Council to review. Staff Recommendations: That the council receives this report. That it be included under the West Coast angling ethics and widely publicized that - Fish & Game encourages a maximum take of six of sea-run salmon per season on the West Coast. That the use of single hook should be encouraged in South Westland lakes and the proposed regulation be revisited in 2024 regulation review in combination with a survey to assess the success of voluntary usage. That Lake Haupiri be closed over the winter season (1st May to 30th September). That the council reviews suggested changes to regulations listed in appendix five.

Introduction

Following the December 2015 West Coast Fish and Game Council Meeting, it is now West Coast Fish and Game policy "That the West Coast Fish and Game Council conduct a consultation process with licence holders regarding key regulation proposals being considered for implementation in sufficient time to enable the feedback to be considered for regulation setting in 2016 and use this as a basis for a 3 yearly regulation set to be reviewed 3 yearly." West Coast licence holders were surveyed again in 2018 and now six years on from the policy being formed, another review and survey is due. During the last three years both the South Westland lake's salmon populations and the winter closure of smaller West Coast lakes have been very topical at both the council table and discussions with licence holders. This discussion formed the basis of the following three regulation proposals that were put out for consultation, approved by the West Coast Fish and Game Council at their October 2021 meeting.

Method

The survey was carried out using Survey Monkey which is an online survey provider. West Coast Adult and Family Licence holders were sent an email that included a link to the survey, as well as stating that they have a chance to have their say on Freshwater Sports Fish Regulations. The email was sent on the Wednesday the 3rd of November 2021, and the survey closed on Friday the 19th of November 2021. Giving West Coast licence holders 16 days to complete the survey if they wished to have say on the proposed regulation changes or suggest any other potential changes. Of the 2,206 invited to participate, 242 completed the survey, that being 11% of invited licence holders.

For the purpose of this report all graphs will be given as percentages to allow ease of comparison. Given that every West Coast licence holder with a valid email address was encouraged to participate,

all was done to ensure the survey is representative of the West Coast licence holder population. For the survey questions please refer to appendix one.

Results


The survey revealed that it is estimated 88% of licence holders support the implementation of a season bag limit of six sea-run salmon on the West Coast.

The survey revealed that it is estimated 77% of licence holders support the implementation of a single hook rule for South Westland lakes.




Q2 Do you support or oppose the implementation of a single hook rule for South Westland Lakes?

The survey revealed that it is estimated 84% of licence holders support the closure of Lake Haupiri over the winter season (1st May to 30th September)






Figure 3: West Coast licence holders' stance on the implementation of the closure of Lake Haupiri over the winter season.

Discussion

The implementation of a season bag limit of six sea-run salmon on the West Coast

Despite 88% of survey responders supporting the implementation of the season bag limit, it comes with a significant financial and compliance burden to address a low occurring issue of individuals exceeding salmon numbers of which a majority of angler's view beyond what's acceptable. Regulations need to be based on protecting the fishery followed by maximizing opportunities for anglers. Without any evidence to support that the few anglers that harvest high numbers of salmon are having a detrimental effect on the population we can only encourage ethical angling behavior. Lastly the season bag limit creates another barrier to participation with additional regulations and the requirement to hold a season bag limit card, likely causing confusion and an imposition, resulting in reduced participation. Therefore, its recommended that it be included under the West Coast angling ethics and widely publicized that - Fish & Game encourages a maximum take of six of sea-run salmon per season on the West Coast.

The implementation of a single hook rule for the South Westland lakes

With 77% of survey responders supporting the implementation of a single hook rule for South Westland lakes it still leaves a significant portion of opposed anglers. With no scientific evidence to support the anecdotal reports and not wanting to force unnecessary restriction on anglers a

voluntary approach should be adopted. Therefore, it is recommended the use of single hook should be encouraged in South Westland lakes in hope of improving catch and release survival.

The proposed regulation should be revisited again during the 2024 regulation review in combination with a survey of anglers to assess adoption of the single hook and their experiences in doing so.

The closure of Lake Haupiri over the winter season (1st May to 30th September)

With 84% of survey responders supporting the closure, evidence of a seasonal influx of spawning trout, the findings of the recent survey of Lake Poerua being a similar fishery, and lastly it being an abnormality to current regulations there is good rationale to implement the closure. Therefore, its recommended that Lake Haupiri be closed over the winter season (1st May to 30th September).

Staff Recommendations

- That the council receives this report.
- That it be included under the West Coast angling ethics and widely publicized that Fish & Game encourages a maximum take of six of sea-run salmon per season on the West Coast.
- That the use of single hooks should be encouraged in South Westland lakes and the proposed regulation be revisited in 2024 regulation review in combination with a survey to assess the success of voluntary usage.
- That Lake Haupiri be closed over the winter season (1st May to 30th September).
- That the council reviews suggested changes to regulations listed in appendix five.

- Treble hooks tend to be more reliable hooking a fish. Implementing a ban on them is only going to hurt the average joe trying to catch a feed. People fishing just to release them shouldn't be doing that in the first place any hook will do damage. Catch them to EAT. OPPOSE

- Without conclusive evidence it doesn't make sense. Education on fish handling, to return sublegal or any fish, to the water would have a better outcome.
- If the scientific literature is inconclusive there isn't a valid factual basis to support the change.
- While the concept is good for salmon fishing, my experience as a keen catch and release trout fisher on Lake Moeraki who tried single hooks for considerable time was that it is very difficult to catch fish with a single hook whereas a treble hook was much more successful. You have noted that the scientific review was inconclusive. Clearly this is an issue for salmon fishing however Lake Moeraki and other South Westland lakes are all-year-round fisheries. As such the approx 2 month Salmon fishing season is only 1/6th of the year. Is it possible to require single hooks to be used for salmon fishing but trebles to still be acceptable for trout fishing or acceptable in the April to December period?
