The manager informed the councillors that Wayne Pepper has formally resigned from the Northland Fish & Game Council due to work commitments. Councillor Chris Lynch is in the process of selling his house and moving away from the Northland region. Mr Lynch will formally resign when he undertakes his relocation which is probably at the end of the year.

**Matters Arising**

**Fish & Game Review Meeting**

The Chairman thanked the councillors for attending the review meeting on the 15<sup>th</sup> September. All councillors and staff had an opportunity to voice their opinions on Fish & Game matters and structure.

**Manager's Report**

**Flaxmill Wetland**

Mr Edwards, the new owner of the adjacent farm, has notified the council that an engineer's report for slips caused by the last floods is required before any repairs to the bridge are made. The total bill for the report is estimated approximately 5-6k and Mr Edwards has requested that Fish & Game pay 50% of the estimate. The councillors discussed their options.

**It was moved:** *Due to this new information, Northland Fish & Game Council will rescind the motion to pay no more than 50% of the costs to a maximum of \$25,000 for building repairs to the bridge suitable for Fish & Game purposes. Northland Fish & Game agree to commit up to \$3,000 for the engineers report.*

### **Kai Iwi Lakes**

The manager wishes to advise the licence holders that the stocking of the lakes was not approved this year by the Taharoa Governance Committee and their reasons. There is a lot of information circulating on the social media about the future of the fishing at the lakes.

Advice received from the KDC is that the Department of Conservation has made a commitment to the Taharoa Domain Governance Committee that they will develop a research and management strategy for the Dune Lakes Galaxid.

The council will also write a letter to the Minister of Conservation after the upcoming general election on the 17<sup>th</sup> October, requesting the department to look into this matter. The council will approach the media after a response from the Minister is received.

### **Water Consents**

Fish & Game received two water consents applications from NRC seeking comments for the 2 applications for the irrigation reservoirs planned for Dargaville and Kaikohe.

### **Ranger Compliance**

An advertisement was placed on Trade Me regarding the sale of game birds. Ross Atkinson from DOC has dealt with this matter and has also contacted Trade Me about the offence to advertise any sale of game birds. Trade Me withdrew the advert immediately.

### **NZFGC Updates**

Councillor Birchall has attended the 147<sup>th</sup> NZC meeting in Wellington. Councillor Birchall gave a brief update on the following:

- The NZFGC Chairman has invited the President of the Federated Farmers to meet and discuss environmental matters.
- Resource Allocation Project has commenced with consultants being appointed and Fish & Game reference group also being appointed. A report may be out for consultation by the end of the year.
- Pheasant Preserves. The Minister of Conservation is seeking Fish & Game's advice on the preferred option. The recommendation sent to the Minister was to remove the sunset time clause which will allow the existing preserves to operate but would require a regulation change for any new preserve to open.
- Reserves Policy. The SFC committee presented a late paper which is now refined and gone out to regions for comment.
- Two motions for the Mallard Research and Non-resident levy were both confirmed.
- Trout Farming.
- Updating National Policies.

The Chairman and Councillors appreciated Councillor Birchall input into the NZ Council and thank him for all the extra work he puts into Fish & Game.

### **Non-resident levy**

NZ Council agreed that all licence and non-resident fishing licences will be treated as income and that all non-resident reserves become general reserves in the regions in which they are currently held. At present the non-resident levy is considered as a dedicated reserve. In the 2019-2020 year end accounts, this levy will be transferred to a General Reserve.

### **Salmon Proposed Commercial Origin Release Policy**

NZ Council is seeking feedback from the regions on a proposed Commercial Origin Salmon Release Policy. The policy prevents the release of commercial origin salmon into open systems of water where they may compete with wild fish but does not prevent releases into closed systems of water.

### **Trout Farming**

The council discussed the risks and benefits associated with trout fishing in NZ. The Northland Fish & Game region agreed to the following recommendations made by NZ Council:

1. Agree to reassess Fish & Game's opposition to trout farming based on further independent research establishing the risk profile of different types of trout farming systems
2. Agree to reject and advocate against the importation of trout flesh.
3. Agree to consult with regional Fish & Game councils on the outcome of this paper.

**It was moved:** *That NFGC agrees with the historical position of NZFGC on the grounds for opposition of the importation and sale of trout products.*

### **Reserve Policy**

A late paper on the draft policy on the accumulation, management and application of reserves within Fish & Game was circulated for regional councils to provide feedback to NZ Council. As the current council meeting had a reduced number of councillors, the chairman decided the following:
